11. District's CEO Report – Ida reported that on 10/7/23 we will partner up with the Main St. Middle School as they host their yearly flu clinic. Our clinic will be there to help them with this event. On 9/23/23 Ida, Graig and Jovanna attended the ribbon cutting event for the new resource center. Ida attended the ACHD 71st Annual Meeting that was held on 9/12/23 through 9/15/23. Ida will be joining the City of Soledad General Plan Committee. The Foundation has applied and been accepted to be part of the MC Gives Campaign this year again. The focus is our Comprehensive Perinatal Education Program. Ida shared with the board the Campaign letter and details on how to donate. On 5/5/23 we applied for a medical capacity grant where we were awarded \$234,000. In July we received \$187,000 of that grant and will receive a final payment in October. On August 26th we opened a Saturday clinic. We were able to see 37 adolescent and children patients. Loan documents have been signed to renew our \$250,000 line of credit for another year. Eden Valley's census for today is 54 total with 18 Medicare. This month we received 22 referrals from SVMH and 1 from Natividad. Jovanna Velasquez has been promoted to the Clinic Supervisor at the Clinic. We partnered up with the Soledad Rotary Club and helped with the Women's Resource Fair. Ida attended the National Health Care Advisory Group. Ida reminded the board that the ethics training will no longer be provided by the Fair Political Practices Commission.


